

### European Parliament Parliament's powers

### Legislative power

Most EU laws are adopted jointly by the European Parliament and the Council of the EU



#### **Parliamentary control**

Parliament supervises other EU institutions and can pass a vote of no-confidence in the European Commission



Parliament decides the EU annual budget together with the Council

#### **Enlargement decisions**

Parliament's assent is required for the accession of any new Member States













### Budget of the European Union Financial year 2009





### EU Budget Revenue Financial year 2009




